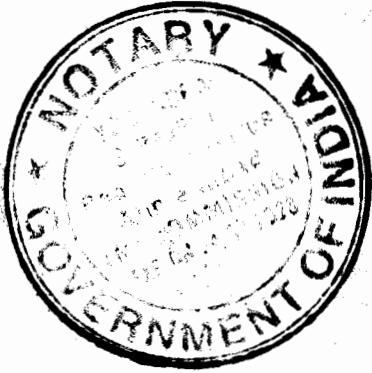

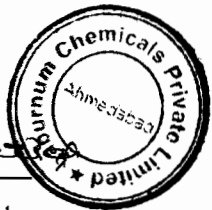
Memo Regarding Withdrawal of the Present Appeal
